- 3. Flexibility:** You can start or stop an SIP at any time, increase or decrease the investment amount, or switch funds based on your

financial goals.

- 4. Compounding Power:** By staying invested for a long period, you benefit from the power of compounding, where you earn returns not just on your initial investment but also on the returns generated over time.
- 5. Low Initial Investment:** You can start an SIP with a small amount (as low as ₹500 or ₹1000), making it an accessible option for all investors.
- 6. Risk Mitigation:** SIP reduces the impact of market volatility, as investments are spread over time, and reduces the emotional aspect of trying to time the market.
- 7. Convenience:** It's easy to automate the investment process, as most SIPs allow auto-debit from your bank account, ensuring timely investments without any manual effort.
